

**BINGOL UNIVERSITY**  
**2020-2021 ACADEMIC YEAR ADDITIONAL ANNOUNCEMENT FOR INTERNATIONAL STUDENT**  
**ADMISSION TO ASSOCIATE AND BACHELOR / UNDERGRADUATE PROGRAMS**

**1- GENERAL**

Provided that the candidates have the qualifications indicated at “the directive for international student applications, admissions and registrations to undergraduate programs” and meet the principles published on the website [www.bingol.edu.tr](http://www.bingol.edu.tr) being accepted by the University Senate and approved by the Higher Education Council; thus **international student application** could be done via the website.

**2- REQUIREMENTS FOR APPLICATION**

a) Provided that the applicants are senior class high school students or high school graduates in case of the fulfilment of the following principles:

- 1) Foreign nationals,
- 2) Those who are Turkish citizens by birth but with a later permission for renouncement of nationality by the Ministry of Interior and those who provide evidence that their under age children registered in the document of renouncement of nationality have a Document on the Use of Recognized Rights by the Turkish Citizenship Law (Article 7 of the Turkish Citizenship Law no: 5901 states the following: “(1) Children who are born during the marriage of a Turkish mother or father in Turkey or abroad are Turkish citizens.” and the candidates abroad to apply to admission quotas are advised to view the Turkish Citizenship Law.),
- 3) Foreigners who have had the right to the certificate of naturalisation of the Turkish Republic as citizens / those who have dual nationality under similar conditions,
- 4) \*a) Turkish students who attended secondary schools abroad before the date of 01/02/2013, including those who have completed the last three years of their secondary school (high school) education in a foreign country except for Cyprus and those who have completed their whole secondary school (high school) education Turkish schools under the supervision of the Ministry of National Education (MoNE) in a foreign country except for Cyprus),
- b) Candidates of foreign student admission quotas who started secondary school education abroad after the date of 01/02/2013, including those who have completed their whole secondary school (high school) education in a foreign country except for Cyprus and those who have completed their whole secondary school (high school) education Turkish schools under the supervision of the Ministry of National Education (MoNE) in a foreign country except for Cyprus),
- 5) Cyprus citizens who live in Cyprus and those who have completed their secondary school education (high school) in Cyprus high schools and have received GCEAL results and those who were registered at and attended private schools and high schools in other countries between 2005 and 2010 with GCE AL examination results or those who will receive such results,

Application may be done.

b) The following applicants can not apply:

- 1) Turkish students who have completed their whole secondary school education in Turkey or in Cyprus,
- 2) Cyprus citizens (except for those who have completed their whole secondary school education (high school) in Cyprus high schools and have received GCE AL results and those who were registered at and attended private schools and high schools in other countries between 2005 and 2010 with GCE AL examination results or those who will receive such results),
- 3) \*Those who have dual nationality, the first of which is Turkish by birth as stated in Article a, clause 2 (except for those who meet the conditions stated in Article a, clause 4)

- 4) Those who have dual identity, one of which is Cypriot, except for those who have completed their whole secondary school education (high school) in Cyprus high schools and have received GCE AL results and those who were registered at and attended private schools and high schools in other countries between 2005 and 2010 with GCE AL examination results or those who will receive such results),
- 5) Turkish citizens who attend schools in Turkey under the supervision of embassies and foreign high schools in Turkey or those who have dual identity, the first of which is Turkish by birth, as stated in Article a, clause 2.

### 3- REQUIREMENTS FOR A SUCCESSFUL APPLICATION

For the academic year 2020-2021; applicants must meet at least one of the requirements stated in the table below for a successful application.

8	University entrance exam (Gaokao) done in the Republic of China.	Getting at least 500 out of 750 scores at the type of the applied program.
9	Al-Shahada-Al Thanawiyya (Baccalaureate) exam done in Syria	Having minimum 185 scores out of 240 in Science (Scientific Stream) for the departments of Engineering Faculty, getting at least 170 points for other departments.
10	The International Science Olympics recognized and participated by TÜBİTAK	Having gold, silver and bronze medals
11	Al-Shahada-Al Thanawiyya (Baccalaureate) exam done Libya	Having minimum 185 scores out of 240 in Science (Scientific Stream) for the departments of Engineering Faculty, getting at least 170 points for other departments.

#### 4- APPLICATION PROCESS

Applications will be done from the [international student application](#) web address.

#### 5- EVALUATION OF THE APPLICATIONS

Assessment of the applications and placement of the candidates are under Bingöl University's authorization. Candidates with missing documents will not be evaluated. Placement will be done by the foreign student placement commission.

Placement Method: The applied points will be converted to a common score by the commission and the placement will be done according to the preferences starting from the higher scores.

#### 6- FINAL REGISTRATION DATES, DOCUMENTS AND TUITION FEE

Final registrations of the students who are placed in the university will be done between the dates of 07-11 September 2020 at Bingöl University **International Student Coordination Office**-Bingöl.

##### 1) Final registration documents

- a. Exam result document,
- b. High school diploma,
- c. Transcript,
- d. Education legitimate passport,
- e. An Equivalence Letter from the Ministry of Education of Turkey or from the Turkish Embassy Education Counsellor in their country, certifying that the diploma is equivalent to a Turkish High School Diploma
- f. Residence permit (from the Directorate of Migration Management),
- g. Bank receipt indicating that the tuition fee has been paid,
- h. An internationally valid document indicating that the candidate has financial means to sustain higher education
- i. General Health Insurance Policy, (Must apply to the Social Security Institution to pay the health premium.),
- j. Document showing the Turkish language level,
- k. 4 photos (4,5x6 size, taken in the last six months).

**NOTE:** (a, b, c and d documents must be approved by the Turkish Embassy or Consulate in their country)

Candidates who are Turkish citizens by birth and who lost their Turkish citizenship by obtaining permission from the Ministry of Interior to get out of Turkish citizenship,

In respect to the general assembly decision of Council of Higher education, dated 04/07/2019, student allocation will be done for 10% of the quotas in the departments of Teacher Education, Dentistry, Law and Medicine, among the candidates who hold blue card or Turkish citizens who have completed their high school education abroad (except TRNC) or dual nationality owners whose one of the nationalities is Turkish Republic.

**Article 121.** One-year mandatory Arabic Preparatory Program is implemented. The preparatory class is not included in the years shown at the duration column. Those who pass the Arabic proficiency exam will be taken directly to the first class. Students are subject to the provisions of the "Regulation on Foreign Language Teaching in Higher Education Institutions and the Principles to be followed in Teaching Foreign Languages".

**Article 708.** The language of instruction in this program is at least 30% Arabic Language.
